DAMAGE TO OUR VEHICLES IS YOUR RESPONSIBILITY

1. Must read carefully
2. Sign c/c authorization slip
3. Check all boxes, initial & sign where indicated in agreement
4. Supply c/c information for pre-approval for any damages to our bikes beyond the amount provided for the cash damage security

Cash Security - Due at time of tour

\$300.00 Cash per person

_____(Initial): Cash will be due during our rider's meeting on the first day of the tour. This is in addition to your credit card being on file, in the event of any damage to the Motorcycle you will be operating. *Your cash will be refunded at the conclusion of the event, less any damages.*

_____(Initial): I agree to pay for any and all damages incurred to the machine I will be operating on this tour. I understand that there is a \$300.00 Motorcycle cash deposit per person, which I will give to GBGD on our first tour day that serves as a security deposit for any such damages. In the event the damages incurred upon my machine exceed the \$300.00 Motorcycle cash deposit, I give GBGD the right to collect the remaining balance in full by cash or by credit card.

_____(Initial): I will ride safely in a manner consistent with the tour rules and guidelines as set forth by GBGD for the safety and protection of all parties involved. Misconduct or blatant disregard for tours rules and safety guidelines will be cause for immediate termination of one's tour.
